All pencils manufactured and sold by MUSGRAVE PENCIL CO., INC. will be manufactured from components supplied by approved component manufacturers.

I understand that WIMA will use its best efforts to add new raw material components suppliers to its approved list within a reasonable time, subject to the medical advisor's approval, and that my company may at any time request new raw materials or component suppliers be added to the WIMA approved list.

The PMA mark is a registered certification mark number 953,889 issued February 20, 1973 and shall be depicted as illustrated.

The ingredients of cased pencils bearing the PMA mark have been approved by a nationally recognized medical authority, associated with a leading university, and are certified to contain no known toxic materials in sufficient quantities to be injurious to the human body even if reasonable amounts are ingested.

In addition, the PMA mark certifies that cased pencils so labeled do not require acute toxicity labeling under the Federal Hazardous Substances Act, 15 U.S.C. & 1261 et seq., (or latest revision) to minimize hazards to children from residual surface coatings materials and do not require chronic toxicity labeling under the criteria of American Society for Testing and Materials Standard D 4236-83 for chronic hazard labeling.


